

# **AFFILIATION FORM**

Under the Rules of Incorporation of the Frankston & District Netball Association, Clubs must be affiliated with the Association. The Affiliation is divided into two (2) classes:

- 1. Clubs with both Senior and Junior teams or three (3) or more Senior teams or three (3) or more Junior teams shall become Member Clubs with full voting rights.
- 2. Other Clubs shall become Associate Clubs without voting rights.

Team numbers referred to in (1) above shall be calculated from the number of separate teams entered in all competitions in the previous affiliation year.

#### In addition:

- 1. Associate Clubs may apply to become Member Clubs after one (1) full year of affiliation.
- 2. Any new Club affiliating with the Association shall be an Associate Club in the first year of affiliation. Thereafter clauses (1) and (2) apply.
- 3. A Club must be affiliated with the Association before that Club is permitted to enter a team/s in any competition conducted by the Association.
- 4. The affiliation fee is incorporated into the Team Entry Fee.
- 5. Under the By-Laws passed at the A.G.M. on the 23rd October 2002, a Club/Team must be an Incorporated body to compete in the Saturday Winter Competition.

### TERMS & CONDITIONS

- The Affiliation provides Clubs with insurance cover for their members including Public Liability, Personal Accident and Professional Indemnity, access to F.D.N.A. & Netball Victoria events, programs and services, advice and advocacy on Club administration and management.
- ❖ Affiliated Clubs must return to F.D.N.A. the official registration form to ensure full insurance cover for the club
- Clubs will comply with policy, regulations & By-Laws as advised from time to time by the Board of Management of Frankston District Netball Association
- Clubs must nominate a voting delegate who has the authority to vote on any matter advised by Frankston District Netball Association that requires a vote.
- Clubs must advise Frankston District Netball Association immediately of any change to Secretary, Voting Delegate or Committee member/s of the Club.

### DISCIPLINE OF AFFLIATED CLUBS

- (a). Subject to these Rules, the Board may by Resolution:
  - I. expel an Affiliated Club from the Association
  - II. suspend an Affiliated Club from membership of the Association for a specific period; or
  - III. fine a Affiliated Club in accordance with the Regulations under the Associations Incorporated Act if the Board is of opinion that the Affiliated Club:
    - ❖ has refused or neglected to comply with the Rules; or
    - ❖ has been guilty of conduct unbecoming an Affiliated Club or prejudicial to the interests of the Association
