



## **AFFILIATION INFORMATION**

Under the Constitution of the Frankston & District Netball Association, Clubs must be affiliated with the Association. The Affiliation is divided into two (2) classes:

1. Clubs with a minimum of three (3) Junior teams may apply to become a member Club with full voting rights.
2. Clubs with less than 3 teams shall be known as Provisional Clubs without voting rights.

Team numbers referred to in (1) above shall be calculated from the number of separate teams entered in all competitions in the previous affiliation year.

In addition:

1. Provisional Clubs may apply to become Member Clubs after one (1) full year of provisional affiliation. Clubs may be considered Provisional for a period of up to three (3) years.
2. Any new Club affiliating with the Association shall be a Provisional Club in the first year of affiliation. Thereafter clauses (1) and (2) apply.
3. The affiliation fee is incorporated into the Team Entry Fee.

## **TERMS & CONDITIONS**

- ❖ The Affiliation provides Clubs with insurance cover for their members including Public Liability, Personal Accident and Professional Indemnity, access to F.D.N.A. & Netball Victoria events, programs and services, advice and advocacy on Club administration and management.
- ❖ Affiliated Clubs must return to F.D.N.A. the official registration form to ensure full insurance cover for the club
- ❖ Clubs will comply with policy, regulations & By-Laws as advised from time to time by the Board of Management & Staff of Frankston District Netball Association
- ❖ Member Clubs must nominate a voting delegate who has the authority to vote on By-law and Constitutional matters, as advised by Frankston District Netball Association.
- ❖ Clubs must advise Frankston District Netball Association immediately of any change to Secretary, Voting Delegate or Committee member/s of the Club.
